# SAN JOAQUIN COUNTY SUPERIOR COURT CYBERSECURITY UPDATE

We continue working alongside our third-party experts to investigate the recent cybersecurity incident and securely restore our network.

As we continue to bring services back online, the current status of operations across various departments is outlined below. Please continue to visit <u>sicourts.org</u> for the most up-to-date information moving forward.

#### **Operational Update**

The following systems have returned to normal operation via the Online Services section of the court's website:

- Support assistance from the Clerk's Office
- eFiling
- On-line Dispute Resolution: online resolution of traffic citation cases, including fine and fees payment, rescheduling a court hearing, request to reduce fines, fees and release of DMV hold, if applicable, request a Court Trial or a Trial by Declaration
- Probate Notes and Tentative Rulings

At this time, due to our proactive containment efforts, part of our network remains offline. Our manual workarounds remain in place, but the following in-person and online services are temporarily unavailable:

- Credit card payments cannot be processed at our counters but an authorization can be submitted with the filing.
- Case Management Search
- Case Management Tutorials
- Ability to Pay requests
- On-line Records Request
- Juror notification subscription
